AMRA fends off Forest Service

Federal agency claims suction dredge mining an afternoon fire hazard

The U.S. Forest Service is picking up where the Environmental Protection Agency left off in Idaho, said American Mining Rights Association President Shannon Poe.

After attending the Occupy Idaho Waters II event hosted by the Southwest Idaho Mining Association in July, AMRA members headed north to one of their newest claims on the Clearwater River. About 25 small-scale suction dredgers mined on the river for a week undisturbed until the Forest Service sent out one of its law enforcement officers. The offier came to inform the miners that they would have to shut off their suction dredge engines by 1 p.m. every day because they were fire hazards, Poe said.

"What they were trying to do is shut dredging down this year, and they were just gonna use whatever method they could come up with." Poe said. "This thing they passed out stated that we were in an off-road activity—according to this notice signed by three different Forest Service supervisors—and it stated that we had to turn our motors off at one o'clock because they posed a fire danger, but in this case they had some exclusions that said if you have a generator in your camp, as long as you cleared a three-foot circle on the round, you could run a generator."

While the generator was a permissible exclusion, a dredge in the middle of the river was not, according to the Forest Service officer, Poe said.

"We measured my dredge and it wwas 40 feet from the nearest point of any vegetation because it was sitting out in the middle of the river that's 105 feet wide," he said.

Poe and several other AMRA members leapt into action, driving to Grangeville, Idaho to meet with the sheriff's department as well as Idaho County commissioners. Poe also proceeded to call staqte and local representatives and alert fellow members via social media.

"By the time I got a hold od the guy that was allegedly in charge of this ridiculous closure, I told him, "Look, if you shut us down, you're going to have to shut down all the commercial jet boats on the Salmon River if you're going to use that same

ideology that any motorized combustion engine in the middle of a river is gonna cause a danger," Poe said. "They never considered that; they were just targeting us. He admitted that it didn't apply to us and we could go back dredging."

But, that wasn't the end of it. The next day Forest Service Geologist Cling Hughes showed up, Poe said.

"He handed two of our AMRA members a notice of noncompliance saying we could not dredge any longer and that we had to cease and desist and remove all mining equipment from 'the forest,'" Poe said.

So, Poe fired back, questioning Hughes' authority and citing the laws and cases that allowed the iners to dredge legally.

"He couldn't cite anything. I put hi on notice, which is called constructive and direct notice, that his ignorance of the law is no excuse for him to violate all of our rights, and because of that, we would sue him if he continued his harassment. Well, he did," Poe said. "His entire goal is based on political ideology."

Again, AMRA was forced to contact the Idaho County Sheriff's Department, which is headed by Sheriff Doug Giddings, who has fully supported the miners since day one, voicing that support on record at the 2014 hearing conducted by the Idaho Senate Committee on Resources and Environment and the House Committee on Resources and Conservation.

"We called (the sheriff's department) and the same undersheriff, Jim Gorges, showed up and told Clint Hughes, 'These boys have come a long way; they all have their Idaho state dredge permits, and you're materially interfering with them. They need to go back to work and you need to quit bothering them.' That diffused t and he left." Poe said.

Though Hughes did not return again, Poe said five miners received non-compliance notices. He also said AMRA intends to sue Hughes for his "harassment."

"He's got some very, very serious civil liability issues, and I am going to sue hi individually; we're working on that right now," Poe said. "Whatever political ideology you have, it doesn't trump law. It doesn't trump case law and the Constitution."

Despite five days worth of distractions, Poe said the trip paid off. He alone averaged between half an once and one ounce of color per day, totaling a half-poind of gold in nine days.

Unfortunately, what happened in Idaho is just a taste of what is going on in neighboring states, such as Oregon and California.

"They're just throwing things at the wall to see what sticks," Poe said. "The primary thing that we really need to convey is that everybody should be up in arms. They need to join the cause whether it be with AMRA, Western Mining Alliance, PLP: I don't really6 care who they join, but they hae to get in this fight and they have to financially support these entities putting their butts on the line like we did in Idaho with threats of arrest."

PROTECT YOUR LAND AND YOUR RIGHTS

The following is a list of action items you can do to help preserve the history, heritage and hands-on living legacy of gold prospecting and mining.

- Write to your federal lawmakers. Visit www.house.gov/representativesss/find to locate your local representative and www.senate.gov to locate your senators.
- Stay informed on regional mining rights issues and oppose federal land grabs such as national monuments, national parks, wilderness areas, wild and scenic rivers and additions to the endangered species act lists in your area.
- Be a watchdog! Keep an eye on Bureau of Land Management and U.S. Forest Service regional district offices. Attend meetings and oppose road closures to existing or future mining claims. Submit public comments so your voice is heard. Request extensions of the public comment periods whenever possible to allow more time for opposition.
- Designate a member of your local GPAA chapter as a mining rights liaison to keep GPAA national headquarters informed about local mining rights issues that affect you and your club at content@goldprospectors.org.
- Stay involved as an active member in the Gold Prospectors Association of America or Lo Dutchman's Mining Association.
- Join a local GPAA chapter and participate in community events to teach others about the heritage of gold prospecting and the importance of small-scale domestic mining to jobs and the economy.

Feds look to expand Joshua Tree National Park, eat up public lands

The National Park Service has begun it's scoping process in efforts to expand Joshua Tree National Park's boundaries by annexing the Eagle Mountain area of Riverside County.

In early August, the NPS held a webinar followed by three public meetings to discuss its interest in annexing this nearly 30,000-acre chunk of public land. Public Lands for the People rallied miners to show up at the Aug. 5 meeting in Joshua Tree and surprise the NPS with 150 miners in opposiotion of the idea.

"They plan on coming out with a draft for presentation this winter," said PLP Vice Presidnt Ron Kliewer. "Nothing is set in stone yet. They're just getting public opiion. I know they want it in the park."

Kliewer daid the NPS contradicted itsel during its public presentation stating that the National Park Service is under-funded, but the expasio would require even more money to fund new roads and facilities. Furthermore, it boasted the thriving bighorn sheep and tortoise populations in this "underutilized area," yet it wants to lure in more visitors.

"all the things they mentioned you can do out there, you can already do out there," Kliewer said. "You'd be able to do less if it were part of the national park.

Namely, Eagle Mountain's inclusion in the park would result in more fees and restrictions on everything from mining to solar production, Kliewer said. In fact, NPS has already filed a request with the Secretary of the Interior to stop any new development in the area for the next two years as it continues its scoping process, he said.

You will see four billboards—the only ones on the whole stretch of highway, two on each side. The road to the camping area is on the right just past the first set of billboards. You will also see a sign pointing to the road for Burro Schmidt Tunnel. Go right on the dirt road and follow it for one mile. Our camping area is on the right. GPS coordinates for the camp site are 35 29' 20" N 117 56' 19" W. To get to the claim, go another aprox. 4 miles past the camp site to a fork that points to EP15 in each direction. 35 29' 3" N 117 57' 5" W Take the one on the left (the shortest and easiest route) Follow the road to the Bonanza Gulch sign. 35 26' 57" N 117 52' 56" W From there, take the very rocky road down to the valley below. You will see the old Post Office in the middle of the valley. 35 26' 41" N 117 52' 56" W This is on our claim. Actual boundaries coordinates will be given later, but are marked with white tipped posts.
